**SENATE AMENDMENT 1,
TO 2001 SENATE BILL 305**

March 6, 2002 – Offered by COMMITTEE ON HEALTH, UTILITIES, VETERANS AND
MILITARY AFFAIRS.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 7, line 5: after that line insert:

3 “**SECTION 7m.** 446.02 (10) of the statutes is repealed.”.

4 **2.** Page 7, line 9: delete lines 9 to 11 and substitute:

5 “448.50 (**1r**) “Diagnosis” means a judgment that is made after examining the
6 neuromusculoskeletal system or evaluating or studying its symptoms and that
7 utilizes the techniques and science of physical therapy for the purpose of establishing
8 a plan of therapeutic intervention, but does not include a chiropractic or medical
9 diagnosis.”.

10 **3.** Page 7, line 16: before “(intro.)” insert “(a)”.

11 **4.** Page 7, line 18: before “(intro.)” insert “(a)”.

12 **5.** Page 7, line 23: before “any” insert “, except as provided in par. (b).”.

1 **6.** Page 7, line 24: delete “(a) to (d)” and substitute “(a) 1. to 4.”.

2 **7.** Page 8, line 1: after “(a)” insert “1.”.

3 **8.** Page 8, line 5: delete “paragraph” and substitute “subdivision”.

4 **9.** Page 8, line 8: delete “(b)” and substitute “2.”.

5 **10.** Page 8, line 10: delete “(c)” and substitute “3.”.

6 **11.** Page 8, line 13: delete “(d)” and substitute “4.”.

7 **12.** Page 8, line 14: delete “pars. (a) to (c)” and substitute “subds. 1. to 3.”.

8 **13.** Page 8, line 15: before that line insert:

9 “**SECTION 12m.** 448.50 (4) (b) of the statutes is created to read:

10 448.50 (4) (b) “Physical therapy” does not include using roentgen rays or
11 radium for any purpose, using electricity for surgical purposes, including
12 cauterization, or prescribing drugs or devices.”.

13 **14.** Page 10, line 9: delete “par. (c)” and substitute “~~par. (c)~~ s. 448.52 (2m)”.

14 **15.** Page 10, line 11: after that line insert:

15 “**SECTION 19e.** 448.51 (2) (c) of the statutes is repealed.

16 **SECTION 19m.** 448.52 (intro.) of the statutes is renumbered 448.52 (1m) (intro.)
17 and amended to read:

18 448.52 (1m) (intro.) A license is not required under this subchapter for any of
19 the following, if the person does not claim to render physical therapy or
20 physiotherapy services as prohibited under s. 448.51 (2) (b):

21 **SECTION 19s.** 448.52 (1) and (2) of the statutes are renumbered 448.52 (1m) (a)
22 and (b).
