ASSEMBLY AMENDMENT,
TO 2001 ASSEMBLY BILL 2

1 At the locations indicated, amend the bill as follows:

2 1. Page 3, line 20: after "(2)" insert "(a)".

3 2. Page 3, line 24: after "year." insert:
4 "(b)".

5 3. Page 4, line 2: delete "once" and substitute "twice".

6 4. Page 4, line 3: after "period." insert "If a question submitted by a local
7 governmental unit relating to substantially similar subject matter or relating to
8 authorization for the borrowing of money is submitted on dates authorized under
9 par. (a) and rejected twice in a 12-month period, no referendum relating to
10 substantially similar subject matter or relating to the borrowing of money may be
11 held by that local governmental unit during the 11-month period following the date
12 of the referendum at which the 2nd rejection occurred."
