ASSEMBLY AMENDMENT,  
TO 2001 ASSEMBLY BILL 4

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 13: delete lines 13 to ~~17~~<sup>16</sup> and substitute:

text: treat

3 "2. Notwithstanding s. 111.322, it is not employment discrimination because  
4 of conviction record for an educational agency to refuse to employ or to terminate  
5 from employment an individual who has been convicted of a felony for a violation that  
6 occurs on or after the effective date of this subdivision .... [revisor inserts date], who  
7 has not been pardoned for that felony, and whose conviction has not been reversed,  
8 set aside, or vacated."
