**ASSEMBLY AMENDMENT ,
TO 2001 ASSEMBLY BILL 4**

- 1 At the locations indicated, amend the bill as follows:
- 2 1. Page 2, line 13: delete lines 13 to 16 and substitute:
- 3 "2. Notwithstanding s. 111.322, it is not employment discrimination because
- 4 of conviction record for an educational agency to refuse to employ or to terminate
- 5 from employment an individual who has been convicted of a felony for a violation that
- 6 occurs on or after the effective date of this subdivision [revisor inserts date], who
- 7 has not been pardoned for that felony, and whose conviction has not been reversed,
- 8 set aside, or vacated."
