


1 At the locations indicated, amend the bill as follows:

2 ② 1. Page 2, line 9: delete lines 9 ^{and} to 10 and substitute "years, or, unless the
3 forfeiture was imposed for violating an ordinance enacted by a 1st class city and
4 unrelated to the juvenile's operation of a motor vehicle, may suspend the juvenile's
5 operating".

6 ⑥ 2. Page 3, line 9: delete lines 9 ^{and} to 10 and substitute "than 30 days nor more
7 than 5 years, or, unless the forfeiture was imposed for violating an ordinance enacted
8 by a 1st class city and unrelated to the juvenile's operation of a motor vehicle, may".

9 ⑨ 3. Page 4, line 3: delete lines 3 ^{and} to 4 and substitute "suspend any license issued
10 under ch. 29 or, unless the forfeiture was imposed for violating an ordinance enacted
11 by a 1st class city and unrelated to the juvenile's operation of a motor vehicle, may".
