Driver be-ware amendment

Representative Johnsrud would like an amendment for introduction on the assembly floor that would maintain that a unit of government can still be held liable for damages to a vehicle if:

If the unit of government knowingly lets a hazard exist on a highway without making a reasonable attempt to repair or to warn the driving public, then the unit of government would still be liable.

The amount recoverable could still not exceed \$50,000.
