Under current law, a volunteer fire fighter, emergency medical technician, or first responder in a city, village, or town whose annual compensation, including fringe benefits, does not exceed \$2,500 may also hold elective office in that city, village, or town. This bill increases the limit to \$15,000.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 66.0501 (4) of the statutes is amended to read:

66.0501 (4) COMPATIBLE OFFICES AND POSITIONS. A volunteer fire fighter, emergency medical technician or first responder in a city, village or town whose annual compensation, including fringe benefits, does not exceed \$2,500 the amount




