ISSUES  
**Analysis by the Legislative Reference Bureau**

Under current law, the department of natural resources (DNR) ~~does not~~ give preference in the issuance of wild turkey hunting licenses to applicants who ~~are~~ qualified resident landowners. Under current law, an applicant is a qualified resident landowner if the applicant owns at least 50 acres in one parcel in an established wild turkey hunting zone and if the applicant agrees to allow other persons to hunt wild turkeys on that land, if they obtain the applicant's permission to do so.

This bill eliminates the requirement that a person, in order to obtain a wild turkey hunting license as a qualified resident landowner, must agree to allow other persons to hunt wild turkey on the land.

**The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:**

3 SECTION 1. 29.164 (3) (b) 2. of the statutes is amended to read:  
4 29.164 (3) (b) 2. For purposes of subd. 1., a qualified resident landowner is a  
5 resident who owns at least 50 acres in one parcel in an established wild turkey
