- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 2, line 1: before that line insert:
- 3 **"SECTION 1g.** 196.218 (3) (b) of the statutes is amended to read:
- 4 196.218 (3) (b) The commission may exempt from part or all of the
- 5 contributions required under par. (a) telecommunications providers who have small
- 6 gross operating revenues from the provision of intrastate telecommunications
- 7 services in this state and who have provided these services for less than a period
- 8 specified by the commission, not to exceed 5 years. ~~The commission may also exempt~~
- 9 ~~a telecommunications provider or other person from part or all of the contribution~~
- 10 ~~required under par. (a) if the commission determines that requiring the contribution~~
- 11 ~~would not be in the public interest."~~
- 12 **2.** Page 2, line 1: delete **"SECTION 1"** and substitute **"SECTION 1r"**.

1 **3.** Page 2, line 4: after the period insert "A surcharge established under this
2 paragraph shall be printed conspicuously in plain English on a billing statement and
3 may not exceed the amount that a telecommunications provider or other person is
4 required to contribute to the universal service fund under this subsection. A
5 telecommunications provider or other person may not establish a surcharge under
6 this paragraph unless the telecommunications provider or other person provides
7 written notice to its customers not less than 30 days nor more than 90 days before
8 establishing the surcharge. The notice may be given as part of a regular billing
9 statement to a customer. No more than 30 days after receiving the notice, a customer
10 may cancel, without penalty, the contract for telecommunications services to which
11 the surcharge would apply."
