2 ✓ 1. Page 1, line 1: after "program" insert ", prohibiting the department of health  
3 and family services from requiring that an individual be a U.S. citizen to ~~receive~~ <sup>be eligible for</sup>  
4 health care coverage under the badger care health care program,".

5 ✓ 2. Page 1, line 3: delete that line and substitute:

6 "SECTION 1d. 49.665 (4) (a) 4. ✓ of the statutes is amended to read:  
7 49.665 (4) (a) 4. The family meets all other requirements established by the  
8 department by rule. In establishing other eligibility criteria, the department may  
9 not include any health condition requirements or require that an individual or any  
10 member of the individual's family be a U.S. citizen.
