ASSEMBLY AMENDMENT,
TO 2001 ASSEMBLY BILL 42

1 At the locations indicated, amend the bill as follows:

2 1. Page 6, line 16: after "Center." insert "The penitentiary near Stanley is
3 named "Stanley Correctional Institution.""

, before the material inserted
by assembly amendment 2,

4 2. Page 5, line 20: after that line insert:

5 "SECTION 8g. 301.065 of the statutes is created to read:

6 **301.065 Rehabilitation facilities at Stanley Correctional Institution.**

7 The department shall emphasize rehabilitation at Stanley Correctional Institution,
8 which shall include programs to provide job training and education to the inmates
9 confined in that facility. The department shall select inmates for these rehabilitation
10 programs so that the participants in the programs reflect the cultural diversity of the
11 inmates in the facility."
