Please note that the attached amendment appears to relate to the type of identification a person must present in order to vote rather than to voter registration. Thus, the amendment may have been intended to modify the nonstatutory provision on page 7 of AB-49 dealing with voter identification and not the nonstatutory provision on page 6 dealing with voter registration. If the amendment is intended to modify the provision on page 7, you may also want to reconcile the amendment with AA-6 to AB-49, which deleted the specific reference to voter identification cards and replaced it with a general reference to voter identification.
