AN ACT to create 20.485 (2) (eg) and 45.035 of the statutes; relating to: the

Korean War memorial at Plover and making an appropriation.

Analysis by the Legislative Reference Bureau

Under current law, money has been provided to construct a memorial to veterans of the Korean Conflict, a memorial to veterans of the Vietnam War and 3 memorials at The Highground in Clark County: one for the veterans of World Way I, one for the veterans of World War II and one for the veterans of the Persian Gulf War. The Korean War Veterans Memorial Association of Wisconsin has created a Korean War memorial at Plover in Portage County This bill appropriates \$90,000 for the perpetual care of the Korean War memorial located at Plover.

an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 20.005 (3) (schedule) of the statutes: at the appropriate place, insert
