

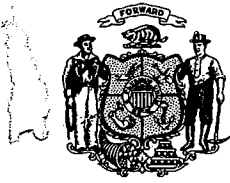

TO 2001 ASSEMBLY BILL 100**

1 At the locations indicated, amend the substitute amendment<sup>v</sup> as follows:  
2 1. Page 5, line 9: after that line insert:  
3 “(c) If an air carrier company that claims an exemption under par. (b)<sup>v</sup> changes  
4 ownership within 5 years from the date that the air carrier company first claims an  
5 exemption under par. (b)<sup>v</sup>, the air carrier company shall pay to the department of  
6 revenue an amount equal to the amount the air carrier company would have paid  
7 under this chapter and ch. 76<sup>v</sup> if the air carrier company had not claimed the  
8 exemption under par. (b)<sup>v</sup>. Any amount paid under this paragraph<sup>v</sup> shall be paid with  
9 interest at the rate of 9% per year.”
