Please draft the following amendments to AB109:

1. Page 3, line 8, replace "mail a copy of the the survey or questionnaire" with "notify the pupil's parent or guardian of the impending survey or questionnaire, its purpose, and information about reviewing a copy of the survey or questionnaire." Feel free to use different words to accomplish the same purpose.
2. Same as above, but add language requiring the school district to keep a copy of the survey or questionnaire on file for public inspection from the date of notification through the balance of the school year.
3. Page 3, line 21-22, change penalty to not more than \$300.
4. Remove the State Attorney General from the enforcement provisions beginning on page 3, line 24. Delete all of page 4, lines 11 - 17.
