Current law permits a school board to provide instruction in human sexuality, reproduction, family planning, human immunodeficiency virus and acquired immunodeficiency syndrome, prenatal development, childbirth, adoption, available prenatal and postnatal support, and male responsibility. This bill provides that if a school board offers instruction in any of these subjects, it must also offer instruction in marriage and parental responsibility.

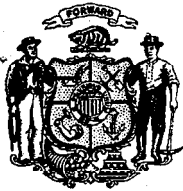
