SECTION 1

SECTION 1. 16.40 (2³) of the statutes is created to read:

16.40 (2³) SALE OF FOREST PRODUCTS AT ~~BADGER ARMY AMMUNITION PLANT~~ (a)

Annually distribute an amount equal to 50% of the amount appropriated under s. 20.505 (1) (n¹) to the school districts located in whole or in part in ~~Sauk~~ ^{Juneau} County in proportion to the number of pupils in each such school district's membership, as defined in s. 121.004 (5), in the previous school year who were residents of that county in the previous school year.

(b) Annually distribute an amount equal to 50% of the amount appropriated under s. 20.505 (1) (n¹) to ~~Sauk~~ ^{Juneau} County for the benefit of the public roads in ~~Sauk~~ ^{Juneau} County.

SECTION 2. 20.505 (1) (ng) (title) of the statutes is amended to read:

20.505 (1) (ng) (title) ~~Sale of forest products at Fort McCoy: funds for public schools and public roads.~~

SECTION 3. 20.505 (1) (n¹) of the statutes is created to read:

20.505 (1) (n¹) ~~Sale of forest products at Badger Army Ammunition Plant;~~ ^{Volk Field} funds for public schools and public roads. All moneys received from the sale of forest products at ~~Badger Army Ammunition Plant~~ ^{Volk Field} under 10 USC 2665 for distribution to ~~Sauk~~ ^{Juneau} County and to the school districts located in ~~Sauk~~ ^{Juneau} County under s. 16.40 (2³).
