ASSEMBLY AMENDMENT,  
TO 2001 ASSEMBLY BILL 168

1 At the locations indicated, amend the bill as follows:

2 ✓1. Page 4, line 8: after that line insert:

*text: treat*

4 “(hm) “Medical equipment seller” means an individual whose employment  
duties include selling or supplying medical equipment or supplies.”

5 ✓2. Page 4, line 13: delete lines 13 to 16 and substitute:

6 “111.337 (1r) (b) Discriminating against any health care provider or medical  
7 equipment seller by engaging in any of the actions prohibited under s. 111.322 on the  
8 basis of the health care provider’s or medical equipment seller’s refusal, or statement  
9 of an intention to refuse, whether or not in writing, based on his or her creed, to  
10 participate in, or sell or provide medical equipment or supplies used for, any of the  
11 following.”
