

The withholding or withdrawal of nutrition or hydration, unless the administration of nutrition or hydration is medically contraindicated, if the withholding or withdrawal of nutrition or hydration would result in the patient's death from malnutrition or dehydration, or complications of malnutrition or dehydration, rather than from the underlying terminal illness or injury.

Amend "activity #7" to read as follows:


7. An act that <u>intentionally</u> causes or assists in causing the death of an individual, such as by assisted suicide, euthanasia, or mercy killing.
