

AN ACT to amend 346.57 (4) (b) of the statutes; relating to: the speed limit at certain intersections marked with school crossing signs and providing a penalty.

## Analysis by the Legislative Reference Bureau

Current law requires a motorist approaching an intersection marked with a "school crossing" sign to slow to 15 miles per hour or slower when children are present.

This bill requires a motorist approaching an intersection marked with a "school crossing" sign to slow to 15 miles per hour or slower when any child or any school crossing guard is present.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

4 SECTION 1. 346.57 (4) (b) of the statutes is amended to read:

346.57 (4) (b) Fifteen miles per hour when passing an intersection properly marked with a "school crossing" sign of a type approved by the department when children are any child or a school crossing guard is present.
