**Assumptions Used in Arriving at Fiscal Estimate**

This bill changes the definition of "barbering and cosmetology" so that it does not include shampooing. The bill creates a shampooing certificate that the board is required to issue to a person who has completed at least 16 hours of training in shampooing in a program approved by the board. The fee for this certificate is \$20 and would "not be subject to periodic renewal."

The costs associated with this legislation include additional board meetings to develop and approve the requirements for the 16 hour program at \$1,000.
