2001 ASSEMBLY BILL 225

March 20, 2001 - Introduced by Representatives LADWIG, SUDER, GRONEMUS, KRAWCZYK, PETTIS, WASSERMAN, OWENS, FREESE, LIPPERT, RYBA, TOWNSEND, J. LEHMAN, ALBERS and MCCORMICK, cosponsored by Senators PLACHE, DARLING and ROESSLER. Referred to Committee on Ways and Means.

1 **AN ACT** to amend 74.09 (5) of the statutes; relating to: mailing property tax
2 bills.

Analysis by the Legislative Reference Bureau

This bill requires that a taxation district clerk mail property tax bills to taxpayers no later than December 31.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 74.09 (5) of the statutes is amended to read:

4 74.09 (5) MAILING. The No later than December 31, the taxation district clerk
5 or the clerk's designee shall mail the property tax bill to each property taxpayer of
6 the taxation district or the taxpayer's designee. If the property tax bill is mailed to
7 the taxpayer's designee, the designee shall furnish the taxpayer with a copy of the
8 bill.

9 SECTION 2. Initial applicability.
