# Analysis by the Legislative Reference Bureau LOCAL-GOVERNMENT

This bill requires DER and the Wisconsin employment relations commission, and DETE if it elects to participate, to organize committees to study and make recommendations on a variety of issues affecting local government compensation and fringe benefits costs. A report of the recommendations must be submitted to the governor, the secretary of administration, and to the legislature no later than January 1, 2003.
