AN ACT ...; relating to: deer hunting back tag number reservation fees.

Analysis by the Legislative Reference Bureau

Under current law, the department of natural resources (DNR) reserves a deer hunting back tag number for a person who pays a reservation fee. Each year, upon payment of the fee, DNR issues the same back tag number to that person. Under current law, a person must pay a reservation fee for a back tag number of \$4.50 together with an issuing fee of 50 cents.

This bill provides that a person is required to pay only a one—time fee for a reservation for a back tag number. Once the fee is paid, DNR must issue the same back tag number to that person each year upon that person's request at no charge. The bill does not change the amount of the fee that a person must pay for the reservation.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 29.561 (1) of the statutes is amended to read:

29.561 (1) COLLECTION OF FEE. The department shall establish a system under


