- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 2, line 9: delete the material beginning with "during" and ending with
- 3 "rule" on line 10 and substitute "during normal retail business hours, as determined
- 4 by departmental rule that is staffed 24 hours a day, 7 days a week".
- 5 **2.** Page 2, line 14: delete lines 14 to 21.
- 6 **3.** Page 3, line 4: delete lines 4 to 10 and substitute "regarding dangerous
- 7 weapons in a public school, the department of justice shall provide the information
- 8 to the appropriate law enforcement agency, as defined in s. 165.83 (1) (b), for the
- 9 municipality in which the public school is located and to the administration of the
- 10 public school. If the department receives information outside normal retail business
- 11 hours and is unable to contact the administration of the public school immediately,

1 the department shall provide the information to the administration at the beginning
2 of the next retail business day.”
