This bill prohibits a person from intentionally being nude in public on land that is owned, managed, supervised, or controlled by the department of natural resources. Under the bill, a person who violates the prohibition is subject to a \$100 forfeiture. *For further information see the state and local fiscal estimate, which will be printed as an appendix to this bill.*

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 23.36 of the statutes is created to read:

4 **23.36 Nudity prohibited. (1)** In this section:

5 (a) "In public" means in a place where a person does not have a reasonable
6 expectation of privacy.

ASSEMBLY BILL 560

SECTION 1

1 (b) "Nude" means not wearing a fully opaque covering over the genitals, pubic
2 area, or buttocks or not wearing a fully opaque covering over the female breast below
3 the top of the nipple.

4 (2) No person may intentionally be nude in public on land that is owned,
5 managed, supervised, or controlled by the department.

6 (3) A person who violates sub. (2) shall forfeit not more than ~~\$100~~
