#### Assumptions Used in Arriving at Fiscal Estimate

This bill would require a change in the examination process to acquire a dental license. There would be no fiscal impact in connection with this change.

This bill would require the Dentistry Examining Board grant licenses to applicants who have been licensed in good standing in another state or territory of the U.S. or Canada. This change would result in additional work for the Division of Professional Credential Processing but the number of additional applicants is unknown at this time. The department believes it can absorb this workload with existing staff.

This bill would require the Board to grant a license to practice dentistry to an applicant who is a faculty member at a school of dentistry in Wisconsin if specified conditions are met. This workload would also be absorbed by the department.

This bill would broaden the scope of practice by dental hygenists. These changes could cause an increase in the number of complaints filed with the department but at this time there is no way to estimate that increase. The Division of Enforcement would absorb the additional workload unless the increase was significant.

This bill requires several new reports that would be submitted to the Governor and the Legislature. The Department of Regulation and Licensing would work with the Department of Health and Family Services to prepare several of these reports. Staff time would be needed in the areas of Health Services Professions, Information Technology and possibly the Division of Enforcement. The Dentistry Examining Board would also be extensively involved in these reports. Several additional board meeting would need to be scheduled. The cost for travel, lodging, meals and per diem would result in an increase of \$3,300. The board consists of 11 at \$300 per member for a total of \$3,300.
