

## 2001 ASSEMBLY BILL 371

May 3, 2001 – Introduced by Representatives KREIBICH, LASSA, TOWNSEND, RHOADES, J. LEHMAN, BERCEAU, BALOW, LA FAVE, PLALE, RYBA, SYKORA, FREESE, KRAWCZYK, BOYLE, GRONEMUS, SHILLING, PLOUFF, CULLEN, MILLER, POCAN, BOCK and OLSEN, cosponsored by Senators GROBSCHMIDT, M. MEYER, BURKE, DARLING, HANSEN, SCHULTZ, COWLES, HARSDFORF and ROESSLER. Referred to Committee on Colleges and Universities.

1     **AN ACT** *to amend* 15.91 of the statutes; **relating to:** appointment of students to  
2     the board of regents of the University of Wisconsin System.

### ***Analysis by the Legislative Reference Bureau***

Current law provides that the governor must appoint one student member to the board of regents of the University of Wisconsin (UW) System and that the governor may select this student member from recommendations made by elected representatives of student governments at institutions within the UW System. This bill requires the governor to appoint two student members, one of whom must be at least 18 years old and selected from the students' recommendations and one of whom must be an undergraduate student who is at least 24 years old and represents the views of nontraditional students, such as those who are employed or who are parents.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

3     **SECTION 1.** 15.91 of the statutes is amended to read:  
4     **15.91 Board of regents of the University of Wisconsin System; creation.**  
5     There is created a board of regents of the University of Wisconsin System consisting
