Under current law, each school board must annually distribute to ~~each~~ <sup>the</sup> parent or guardian of each pupil enrolled in the school district a copy of the school and school district performance report, which contains information such as scores on statewide pupil examinations and attendance and retention rates. This bill requires instead that the school board send each parent or guardian a notice that the report is available upon request, produce a copy of the report upon ~~the~~ <sup>the</sup> request of the parent or guardian, and, if the school district maintains an Internet site, make the report available ~~for viewing~~ at that site.
