ASSEMBLY AMENDMENT,
TO 2001 ASSEMBLY BILL 415

1 At the locations indicated, amend the bill as follows:
2 1. Page 2, line 10: delete lines 10 to 12 and substitute:
3 "SECTION 2m. 29.241 (1) of the statutes is amended to read:
4 29.241 (1) ISSUANCE. A trapping license shall be issued subject to s. 29.024 by
5 the department to any resident applying for this license or to any nonresident of this
6 state applying for this license who resides in a state that allows nonresidents of that
7 state to trap within that state."
