ASSEMBLY AMENDMENT,
TO 2001 ASSEMBLY BILL 425

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 8: delete lines 8 ^{and} 9 and substitute:

3 "961.58 Masking agents. (1) In this section, "masking agent" means a
4 product the primary use of which is to produce a false negative result on a test for
5 the use of a controlled substance.

6 (1m) (a) No person may manufacture, advertise, sell, deliver, or possess with
7 intent to advertise, sell, or deliver a masking agent with the intent".

8 2. Page 2, line 14: delete "any product described".

9 3. Page 2, line 15: delete "in sub. (1) (a)" and substitute "a masking agent".
