2 1. Page 2, line 8: delete that line and substitute:

3 "961.58 Masking agents. (1) (a) In this section, "financial gain" does not  
4 include an increase in an hourly wage set by an employer.

5 (am) No person, with the intent to obtain any financial gain, may manufacture,  
6 advertise, sell,".
