Current law prohibits certain threats to cause bodily harm to the person or family member of a judge, a witness or an official, employe or agent of the department of revenue, department of commerce or department of workforce development. This \* bill prohibits certain threats to cause bodily harm to the person or family member of a social service worker, tefined under the bill to mean an official or an employe of the department of health and family services, a county department of human services, a county department of social services, a county department of community programs or a county department of developmental disabilities services A threat is covered by this prohibition if: 1) the person making the threat knows or should have known that the victim is a social service worker or a member of the social service WATKAN'S family; 2) at the time of the threat, the victim is acting in his or her official capacity or the threat is made in response to any action taken in an official capacity; and 3) the victim did not consent to the threat. A person who violates this prohibition may be imprisoned for up to nine months! fined up to \$10,000 or both.
