You are the drafter for AB 464, LRB-2956, relating to prohibitions related to certain controlled substances.

As the result of a public hearing on the bill, Rep. Staskunas would like you to draft an amendment to this proposal. He would like the penalty for the first offense to be the fine of not more than \$500. The amendment should eliminate the confinement to jail.

Additionally for the second offense, he would like the fine of not more than \$5,000 or imprisonment of not more than two years, but remove the option of both the fine and imprisonment in the amendment.

There is a possibility that this bill will be up for a committee vote next week.
