1 At the locations indicated, amend the bill as follows:

2 1. Page 3, line 2: delete “, as renumbered, is” and substitute “and (c), as
3 renumbered, are”.

4 2. Page 4, line 1: after that line insert:

5 “(e) “Pregnancy program, project or service” means a program, project, or
6 service of an organization that provides services for pregnancy prevention, family
7 planning, as defined in s. 253.07 (1) (a), pregnancy testing, pregnancy counseling,
8 prenatal care, pregnancy services and ^{LA} or reproductive health care services that are
9 related to pregnancy.”.
