ASSEMBLY AMENDMENT,  
TO 2001 ASSEMBLY BILL 555

1 At the locations indicated, amend the bill as follows:

2 1. Page 10, line 7: after that line insert:

3 "SECTION 12m. Nonstatutory provisions.

4 (1) The secretary of administration shall ensure that of the moneys lapsed to  
5 the general fund under 2001 Wisconsin Act 16, section 9101 (23q) (c), and transferred  
6 to the general fund under 2001 Wisconsin Act 16, section 9101 (23q) (d), an amount  
7 equal to \$15,914,400 is used to offset any decrease in tax revenues deposited in the  
8 general fund during the 2001-03 fiscal biennium that may result from the enactment  
9 of this act."
