**ASSEMBLY AMENDMENT 1,
TO 2001 ASSEMBLY BILL 320**

October 4, 2001 - Offered by Representatives JENSEN and PLALE.

At the locations indicated, amend the bill as follows:

1. Page 1, line 4: after "businesses" insert "and requiring the lapse of certain program revenue moneys to the general fund".

2. Page 11, line 3: after that line insert:

"SECTION 129m. Nonstatutory provisions.

(1) VACANT POSITIONS IN THE EXECUTIVE BRANCH OF STATE GOVERNMENT.

(a) In this subsection:

1. "Secretary" means the secretary of administration.

2. "State agency" means any office, department, or independent agency in the executive branch of government, other than the board of regents of the University of Wisconsin System.

(b) No later than 30 days after the effective date of this paragraph, the secretary shall determine for each state agency the number of FTE positions that are funded

7 the 2001-02 fiscal year.
