8 for fiscal year 2001-02 and the dollar amount is decreased by \$929,200 for fiscal year
9 2002-03 to eliminate general purpose funding for the board's general program

11 (2) ETHICS BOARD. In the schedule under section 20.005 (3) of the statutes for
