2 1. Page 5, line 22: after that line insert:

3 “(d) The authority obtains assurance from the U.S. treasury department that  
4 guaranteeing a loan under this section will not make the recipient of the loan  
5 guarantee, or any other eligible borrower under this section, ineligible to receive a  
6 federal loan or other federal aid that would otherwise be available to the recipient  
7 or other eligible borrower and will not reduce the amount of any federal loan or other  
8 federal aid that is available to the recipient or other eligible borrower.”.
