ASSEMBLY AMENDMENT,
TO 2001 ASSEMBLY BILL 576

1 At the locations indicated, amend the bill as follows:

2 1. Page 6, line 16: after that line insert:

3 "(em) The lender agrees that, notwithstanding s. 109.09 (2) (c), during the time
4 that the loan is outstanding and in perpetuity after the loan is repaid, any lien under
5 s. 109.09 (2) (a) against any person that is also indebted to the lender shall take
6 precedence over all other debts, security interests, judgments, decrees, liens, or
7 mortgages held by the lender against that person, regardless of whether those other
8 debts, security interests, judgments, decrees, liens, or mortgages originate before or
9 after the lien under s. 109.09 (2) (a) takes effect."
