

Subject: Pledge of Allegiance / National Anthem & 2/3 Funding of Public Instruction

In response to the Madison School Board's decision to ban offering the Pledge of Allegiance in Madison public schools, please draft a 2001 Assembly Bill that bars school districts from receiving 2/3 funding for public schools unless they offer the Pledge of Allegiance in grades one to twelve each school day. In line with current law that requires all schools to offer the pledge or the National Anthem, but does not require any student to recite the pledge or sing the anthem, school districts under this legislation would not be penalized if a student or students do not participate in the recitation of the pledge.

Please provide me with this legislation as soon as possible.

After talking further with Rep. Albers, please modity her request for legislation, relating to barring the distribution of general school aids to school districts that do not offer the Pledge of Allegiance, as follows:

- 1) Modify the current law requiring schools to offer the Pledge of Allegiance or the National Anthem to specify that offering the National Anthem means to offer both the music and the words.
- 2) Bar the distribution of general school aids to school districts that do not comply with the law.

This differs from the initial request in that Rep. Albers did not originally tie compliance with section 118.06 (2) to general school aids; rather, she wanted a separate requirement to offer the pledge as a condition of receiving aids.

Section #. 118.06 (2) of the statutes is amended to read:

118.06 (2) Every public and private school shall offer the pledge of allegiance in grades one to 8 at the beginning of school at least one day per week. No pupil may be compelled, against the pupil's objections or those of the pupil's parents or guardian, to recite the pledge

(c) The effect of the imposition of the requirement on crime in the school, including weapons possession, assault, battery, and vandalism, and on pupil suspensions and expulsions.

(6) Nothing in this section affects the authority of a school board to require pupils to wear uniforms for extracurricular activities, and the provisions of sub. (3) do not apply to such a requirement.

SECTION 2673p. 118.045 (3) of the statutes is amended to read:

118.045 (3) A school board may commence the school term before September I in any school year if it holds a public hearing on the issue and adopts a resolution to that effect in that school year the school board requests the department to allow it to commence the school term before September I and the school board includes reasons with its request. The department may grant a request only if it determines that there are extraordinary reasons for granting it. The department shall promulgate rules to implement and administer this subsection.
