The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 118.51 (5) (d) ^x of the statutes is created to read:

4 118.51 (5) (d) *Waiting list.* The school board of a nonresident school district may
5 create a waiting list for pupils who wish to attend school in the nonresident school
6 district under this section. ~~The school board may give preference on the waiting list~~
7 ~~to pupils whose parents are employees of the nonresident school district.~~ The
8 department shall promulgate rules to implement and administer this paragraph.
