Here are some drafting notes for an amendment to AB 608:

- ✓ p. 3, line 8 delete private
- p. 3, line 10 delete line and renumber
- ✓ p. 3, line 11 do we need "great bodily harm" when we have "bodily harm" in the sentence?
- ✓ p. 3, lines 14-15 replace with:

✓ The act is intended to influence the policy or conduct of a governmental unit, as defined in s. 939.648, or public officer or employee acting in the course of their official duties, or to punish a governmental unit or public officer or employee for actions taken in the course of their official duties, for a prior policy decision or other official decision or conduct or to intimidate or coerce a civilian population.

- p. 3, line 17 replace "means" with includes
- p. 4, lines 1-2 can we add something to include the components of these physical assets as well as the assets? (i.e. the components of poisonous substances).
- p. 4, line 7 after "knows" add " or has reason to know"

These are a combination of changes proposed by the AG's office and comments made by committee members at the public hearing today. Thank you.

TO 2001 ASSEMBLY BILL 608**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 3, line 7: delete "international".

3 **2.** Page 3, line 8: delete that line and substitute:

4 "(a) "Act of terrorism" means an act committed by a person".

5 **3.** Page 3, line 10: delete that line.

6 **4.** Page 3, line 11: delete that line and substitute:

7 "1. The act is a felony under chs. 939 to 951 or would be a felony under chs. 939
8 to 951 if committed in this state."

9 **5.** Page 3, line 12: delete that line and substitute:

10 "2. The act causes bodily harm or death to another, or in".

11 **6.** Page 3, line 14: delete lines 14 to 16 and substitute:

12 "3. The act is committed with intent to terrorize."

1 **7.** Page 3, line 16: after that line insert:

2 “(b) “Governmental unit” has the meaning given in s. 939.648 (1). ✓

3 (c) “Intent to terrorize” means intent to accomplish any of the following:

4 1. To influence the policy or conduct of a governmental unit or to influence an
5 official policy decision or the official conduct of a public officer or public employee.

6 2. To punish a governmental unit or a public officer or public employee for a
7 prior policy decision, other official decision, or official conduct.

8 3. To intimidate or coerce a civilian population.”.

9 **8.** Page 3, line 17: delete that line and substitute:

10 “(d) “Material support” includes any of the following.”.

11 **9.** Page 4, line 2: after “poisonous substances” insert “or their precursors”. ✓

12 **10.** Page 4, line 3: delete “(d)” and substitute “(e)”. ✓

13 **11.** Page 4, line 7: after “knows” insert “or has reason to know”. ✓

14 **12.** Page 4, line 9: delete “international”. ✓

15 **13.** Page 4, line 10: after “knows” insert “or has reason to know”. ✓

16 **14.** Page 4, line 12: delete “international”. ✓
