AN ACT ...; relating to: graffiti and providing a penalty.

Analysis by the Legislative Reference Bureau

Under current law, a person who intentionally marks, draws, or writes on or etches onto another person's property without the person's consent may be fined not more than \$10,000 or imprisoned for not more than nine months or both. If, however, the property is reduced in value by more than \$2,500, the maximum term of imprisonment is ten years. This bill lowers the damage threshold at which the longer term of imprisonment may be imposed to \$1,000.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 943.017 (2) (d) of the statutes, as affected by 2001 Wisconsin Act, is amended to read:

943.017 (2) (d) If the total property affected in violation of sub. (1) is reduced in value by more than \$2,500 \$1,000. For the purposes of this paragraph, property is reduced in value by the amount which it would cost to repair or replace it or to remove the marking, drawing, writing or etching, whichever is less.


