At the locations indicated, amend the substitute amendment as follows:

1. Page 252, line 2: increase the dollar amount for fiscal year 2001-02 by \$13,800 and increase the dollar amount for fiscal year 2002-03 by \$8,700 to increase funding for the purpose for which the appropriation is made.

2. Page 252, line 6: decrease the dollar amount for fiscal year 2002-03 by \$22,500 to decrease funding for the purpose for which the appropriation is made.

3. Page 522, line 2: after that line insert:

~~SECTION 1375.~~ 38.37 of the statutes is created to read:

**38.37 Crime prevention resource center.** The Fox Valley Technical College shall permit the Wisconsin Crime Prevention Practitioners Association or a person
