TO 2001 ASSEMBLY BILL 629

in 12-13-01

SOON

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 8: after "a." insert "and that represents no more than 25% of  
3 such quarter quarter section".

4 **2.** Page 3, line 1: delete lines 1 to 7 and substitute:

5 "70.32 (2r) (c) 2. For the assessment as of January 1, 2003, and for each  
6 assessment thereafter, the value of an acre of agricultural land under sub. (2) (c) 1.

7 **b.** shall be <sup>no greater than</sup> the average of the value of an acre of pasture land in the previous year and  
8 the value of an acre of land that is classified as swampland or wasteland in the  
9 previous year, rounded to the nearest whole number, except that if the acreage of  
10 agricultural land under sub. (2) (c) 1. b. represents more than 25% of the acreage of  
11 the quarter quarter section described under sub. (2) (c) 1. b. the value of all such land

1 shall not be determined under this subdivision but shall be determined as otherwise  
2 provided in this section.”
