### Analysis by the Legislative Reference Bureau

This bill creates a trust fund designated as the Wisconsin outdoor wildlife heritage trust fund. The bill provides that the fund is to consist of all gifts, grants, or bequests or other contributions made to the fund. The moneys in the fund are appropriated to the department of natural resources to fund programs and activities related to fish and game regulation and the regulation of certain plants.

For further information see the **state** fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 20.370 (1) (Lu) of the statutes is created to read:

20.370 (1) (Lu) Wild animals and plants. From the Wisconsin outdoor wildlife

heritage trust fund, a sum sufficient for activities and programs under ch. 29.


