ASSEMBLY AMENDMENT,
TO 2001 ASSEMBLY BILL 649

1 At the locations indicated, amend the bill as follows:

2 1. Page 4, line 6: delete lines 4 to 6 and substitute:

3 "SECTION 1m. 20.370 (1) (Lu) of the statutes is created to read:

4 20.370 (1) (Lu) *Fish and wildlife habitat*. From the Wisconsin outdoor wildlife
5 heritage trust fund, a sum sufficient for the maintenance and improvement of fish
6 and wildlife habitat." as provided in s. 23.0919

7 2. Page 4, line 6: after that line insert:

8 "SECTION 23.0919 of the statutes is created to read:

9 23.0919 **Wisconsin outdoor wildlife heritage trust fund**. Expenditures
10 from the Wisconsin outdoor wildlife heritage trust fund may be used only for the
11 improvement and maintenance of fish and wildlife habitat. For purposes of this

1 section, improvement and maintenance of fish and wildlife habitat does not include
2 the acquisition of land for such habitat.” ✓
