Analysis by the Legislative Reference Bureau

Under current law, the owner of a snowmobile that has a model year of 1966 or earlier may register the snowmobile as an antique snowmobile. Registration of a snowmobile as an antique entitles the owner to registration decals of a distinctive nature and exempts the owner from having to reregister the snowmobile during the time that he or she owns it.

Under this bill, the owner of a snowmobile that is at least 30 years old at the time that the owner applies for registration may register the snowmobile as an antique snowmobile. Also, after the registrant and any subsequent owner of the antique snowmobile is exempt from paying any additional registration fee.
