The Assembly Ag committee is holding a public hearing tomorrow on SB 339 / AB678, relating to exclusive contracts for the sale of soft drinks in schools.

Sen. Hansen and Rep. Plouff would like to draft an amendment. Is there any chance this could be ready for tomorrow's hearing?

The new language is in red.

Section 1. 118.12 (4) of the statutes is created to read:

SB339, s. 1 - continued

Pg1Ln4 118.12 (4) If a school board enters into a contract that grants to one vendor the
Pg1Ln5 exclusive right to sell soft drinks in one or more schools of the school district, the
Pg1Ln6 school board shall ensure that milk is available to pupils in each school covered by
Pg1Ln7 the contract to the maximum extent possible, whenever and wherever the soft drinks are available to pupils.

SB339, s. 2

Pg2Ln1 Section 2. Initial applicability.

SB339, s. 2 - continued

Pg2Ln2 (1) This act first applies to contracts entered into, modified, extended, or
Pg2Ln3 renewed on the effective date of this subsection.

We also want to add a sentence prohibiting exclusive contracts from prohibiting milk sales.
